

### **Energy Audit**

As per the Energy Conservation Act, 2001, Energy Audit is defined as "the verification, monitoring and analysis of use of energy including submission of technical report containing recommendations for improving energy efficiency with cost benefit analysis and an action plan to reduce energy consumption"

#### The main observations are

Based on the measurement data, and our observation, it is observed that the energy utilisation is very well managed. Some of the very effective steps are highlighted herewith:

- The Visweswaraya block is constructed with well aerated and ventilated class rooms and staff rooms which doesn't require any lighting during day time.
- The pumps for the water pumping system has been selected efficiently and VFD has already been provided
- Lifts are as per latest technology.
- Lighting in the common areas like corridors, basements etc. are by mostly
  CFL lamps with electronic chokes
- The basketball court, canteen and hostel building are equipped with LED lamps
- > Power factor is maintained close to **unity**

The annual electricity consumption for 2018-19 is tabulated and presented as a graph with comparison to LED lightings.

We have identified certain areas especially lighting, having potential for further more energy saving.

We would like to highlight some areas where further more energy can be saved.
